RESOLUTION 2019-10-02

Changes to the Denominational Health Plan Policy Recommended by the Personnel and Finance Committees

Resolved: That the Executive Council of The Diocese of San Diego approve the following plan selection to the denominational health plan policy. The committees recommend no changes from the plans that are offered for 2019.

Resolved: That the bishop's staff in consultation with the appropriate committees revise the wording of the recommendation that was part of the 2019 resolution and present that as a separate resolution at a later date.

Resolved: That the diocese offer the following health insurance plans for 2020:

EXPLANATION

- At the 2009 General Convention, The Episcopal Church passed resolution A177 with two key components:
 - a) Parity is required between clergy and lay employees
 - b) All churches and dioceses must use the Church Pension Group Medical Trust for their health insurance.
- 2. During 2010, the bishop convened a denominational health policy task force to recommend to diocesan convention a diocesan denominational health policy that was in compliance with the general convention resolution. The committee had a number of listening sessions to gather the will of the diocese and to communicate the recommendation. Their work culminated in the recommendation of resolution 12-09, which was passed at the February 2012 diocesan convention. The plan called for a base plan to be the basic EPO Health Plan which has been the Aetna plan. The

Aetna EPO was not offered in 2017 nor were the other EPO plans administered by United Health Care.

- 3. Health Insurance costs continue to rise and are becoming unsustainable for both the church and the employees who are required to fund their family's insurance.
- 4. Consumer driven health plans (CDHP), formerly known as high deductible health plans (HDHP) coupled with a health savings account (HSA) is gaining popularity among dioceses.
- 5. Employees that need family coverage are most at risk with the rise in health insurance costs. This is particularly true with DHP since it does not have age banded rates. Young priests and lay employees are more likely to have families and are having to pay for their family's coverage at the rates that reflect the costs of providing insurance to older individuals. This matter will be discussed in future meetings of the finance committee.
- 6. Premium increases from 2019 to 2020 are from 6.5-7.0% (other than preventative dental, which is 11.65%).
